Other terms

01. All the manpower required shall be made available by the caterer.



02. The Caterer should provide proper and required number of Cutlery/Crockery items like Glasses, serving bowls, plates etc., for serving the food at locations. Replenishing of the items due to breakage/damage is the responsibility of the caterer .
03. The Caterer shall be solely responsible to comply with all Acts, Laws, Rules and Regulations, as may be applicable including food license and shall pay all taxes, debts and / or levies as may be levied by the appropriate Government / Local Bodies and other authorities in this regard
04. The vendor shall not sublet, transfer or assign the contract or any part thereof.
05. The vendor shall comply with all the terms and conditions and ensure supply of the prescribed quantity and quality of food items during the service timings and in the event of any failure or breach of any of the conditions by the Service Provider and in case of deterioration in the quality of the food items or reduction in the quantity thereof, RKCL shall be at liberty to levy penalty for such breach, as mentioned below:.

 - An amount of Rs.1,000/- per instance for Quality / Taste issues as the complaint raised by majority of participants
 - An amount of Rs.500/- per instance for not serving the food item given in the menu without any prior information and approval from the RKCL representative.
 - Amount of Rs.5,000/- per instance or the total food cost of that meal, as deemed appropriate, in case of hygiene Issues like Worms / Insects or any other harmful particles found in food served
